PRIME MINISTER

On behalf of the Unionist people of Northern Ireland we protest most vehemently that you are negotiating the affairs and future of Northern Ireland with a foreign government which not only claims our territory but harbours the murderers of our people and likely some of those who attempted to murder you last year.

As citizens of the U.K. we find it intolerable that behind our backs such nefarious dealings should proceed, particularly insofar as they seek to involve the Ministers and Civil Servants of the Republic of Ireland in the internal administration and policy formation of part of the United Kingdom.

This amounts to a derogation from British Sovereignty, is wholly incompatible with Northern Ireland being part of the United Kingdom and flies in the face of your repeated assurance of Ulster's right to self-determination.

The "Joint Authority" which you rightly declared as "out" last November has come in under another guise. Northern Ireland which you once declared to be as "BRITISH AS FINCHLEY" cannot tolerate this. Ulster is British and DESPITE your treachery is resolved to remain so.

In the Chequers Communique of November 1984 you agreed that "the structures and processes" of Northern Ireland must be acceptable to both communities. Yet you are proceeding to alter these structures and processes with no regard to the acceptability or otherwise of your proposals. We therefore demand that you live


by your own declared yardstick and thus to test at the ballot in Northern Ireland the acceptability of that which you have agreed with Dublin. Why do you fear the democratic process? Live then by your own rules and proceed only with an agreement which is acceptable to both communities.
