

REPORT ON PARLIAMENTARY BOUNDARY COMMISSION FOR ENGLAND'S 1985 INTERIM REVIEW OF PARLIAMENTARY CONSTITUENCIES

I enclose a copy of the Parliamentary Boundary Commission for England's report on their 1985 interim review of 19 Parliamentary constituencies. A summary of their recommendations is annexed to this

I am required by the House of Commons (Redistribution of Seats) Act 1949 to lay this report "as soon as may be" after its receipt. together with the draft of an Order in Council giving effect, with or without modifications, to the Commission's recommendations. The report is published when it is laid before Parliament. The issues to be decided are:-

- (a) whether to implement the final recommendations by a single Order in Council; and
- (b) when to lay the draft Order and arrange the ensuing debates.

The question of whether to modify the Commission's proposals does not arise. The changes involved are minimal and I have received no representations on them. The only objection made to the Commission was about the scope of their report.

Parliamentary Handling

The Government may seek to implement the final recommendations of a Parliamentary Boundary Commission either by a single Order in Council or by a number of Orders. In 1971 and 1973 the then Home Secretary laid 11 and 5 draft Orders respectively following the receipt of reports on interim reviews by the English Commission. However, the Commission's final recommendations on the completion of last year's interim review of 23 Parliamentary constituencies were implemented by one Order in November 1985. So, too, were their proposals following the completion of their second and third periodical reviews of all the Parliamentary constituencies in 1969 and 1983. I therefore recommend that we follow the most recent precedents and lay one draft Order for all 19 constituencies.

- 2 -Timing I propose to lay the report and the draft Order on 20 February to meet the statutory duty to do so "as soon as may be". The draft Order must then be approved by both Houses of Parliament before it can be made by Her Majesty in Council. Once the Order has been made the new boundaries will not take effect until the next general election. However, I think we should arrange the necessary debates as soon as reasonably practicable and certainly more quickly than the seven months it took on last year's review. Unless I hear to the contrary by 13 February I shall assume that colleagues are content with the proposals in this letter. I am copying this letter to the Prime Minister and to other members of H Committee. Youer, Douy17.

ANNEX PARLIAMENTARY BOUNDARY COMMISSION FOR ENGLAND: ANALYSIS OF RECOMMENDATIONS Introduction Section 2(3) of the House of Commons (Redistribution of Seats) Act 1949 enables the Parliamentary Boundary Commission for England to conduct interim reviews of one or more constituencies in its area. Background There had been a number of changes to county, district and district ward boundaries since the completion of the Commission's third periodical review in 1983. These alterations were generally quite small but had divorced the boundaries of the local government areas concerned from those of the constituencies created by the Parliamentary Constituencies (England) Order 1983. The Commission therefore embarked on a programme of interim reviews to remove as many of these anomalies as possible before the next general election. Having reviewed 23 constituencies in eleven areas in 1984, the Commission decided to review a further 19 seats in six counties in 1985. Final Recommendations The Commission's final recommendations (which are identical to their provisional recommendations) propose the minimum change in each area, namely the realignment of the constituency boundary with the altered local government boundary. All of the areas affected by the recommendations contain comparatively small numbers of electors, ranging from 2 to 246. During the review, only one objection was made to constituency boundaries. This came from Sir David Price MP and concerned the boundary between the Eastleigh constituency and the Southampton, Itchen constituency, which was not included in this review. It therefore seems unlikely that there will be any pressure for modifications to the Commission's proposals before the report is laid before Parliament.

- 1. We, the Boundary Commission for England, constituted by the House of Commons (Redistribution of Seats) Acts, 1949 and 1958 and charged with keeping under review the distribution of seats at parliamentary elections in England, submit this Report under the provisions of section 2(3) of the 1949 Act, showing our recommendations with respect to the areas comprised in the following constituencies:
 - (i) The borough constituencies of Eastleigh and Havant and the county constituencies of Basingstoke, East Hampshire, Fareham, North West Hampshire, Romsey and Waterside and Winchester.
 - (ii) The county constituencies of Falmouth and Camborne, St. Ives, South East Cornwall and Truro.
 - (iii) The county constituencies of Keighley and Skipton and Ripon.
 - (iv) The county constituencies of North East Cambridgeshire. South East Cambridgeshire and South West Cambridgeshire.
 - (v) The county constituencies of Bridgwater and Taunton.
- 2. Notice of our intention to consider making a report with respect to these areas was submitted to your predecessor, the Right Honourable Leon Brittan. Q.C., M.P. on 20th February 1985 and was published in the London Gazette on 22nd February 1985. The enumeration date for this interim review is therefore 22nd February 1985 and our recommendations are based on the numbers of parliamentary electors on that date. We issued our provisional recommendations for the areas in (i) to (iv) above on 13th June 1985 and for the area in (v) above on 4th July 1985 and, as required by the Acts, we published these in local newspapers circulating in the constituencies affected. Copies of these recommendations, with illustrative maps, were made available for public inspection at suitable places within the constituencies and facilities were afforded for the submission of representations.
- 3. Our provisional recommendations were framed to take account of changes in local government boundaries which had resulted in their divergence from parliamentary constituency boundaries. The considerations which led to our proposals are set out below. Sketch maps illustrating the recommended changes are contained in the Appendix.
- (i) The borough constituencies of Eastleigh and Havant and the county constituencies of Basingstoke, East Hampshire, Fareham, North West Hampshire, Romsey and Waterside and Winchester.

The East Hampshire and Havant (Areas) Order 1983 came into operation on 1st April 1984 and altered the boundary between the District of East



Hampshire and the Borough of Havant, which had formed the constituency boundary between East Hampshire C.C. and Havant B.C., affecting 65 parliamentary electors. Our provisional recommendation was that the constituency boundary should be altered to conform with the new district boundary. This would transfer 24 electors from Havant B.C. to East Hampshire C.C. and

41 from East Hampshire C.C. to Havant B.C.

The Test Valley (Parishes) Order 1984, which came into operation on 1st April 1984, changed the boundaries of some of the parishes within the Borough of Test Valley and, in consequence, altered the ward boundaries which formed the constituency boundary between North West Hampshire C.C. and Romsey and Waterside C.C., affecting 25 parliamentary electors. Our provisional recommendation was that the constituency boundary be altered to conform with the new ward boundaries, transferring the 25 electors from North West

Hampshire C.C. to Romsey and Waterside C.C.

The Hampshire (Areas) Order 1985, which came into operation on 1st April 1985, altered the boundaries between the City of Winchester and each of the adjoining districts of East Hampshire, Basingstoke and Deane, Eastleigh and Test Valley. As a result the boundaries of the parliamentary constituencies of Basingstoke, East Hampshire, Eastleigh, Fareham, North West Hampshire and Winchester no longer follow the district boundaries in some places. A total of 41 parliamentary electors were affected. Our provisional recommendation was that the constituency boundaries should be altered to conform with the new district boundaries.

Nine parliamentary electors would be transferred from Basingstoke C.C. to Winchester C.C.; two would be transferred from East Hampshire C.C. to Fareham C.C.; six would be transferred from Eastleigh B.C. to Winchester C.C.; three would be transferred from Winchester C.C. to East Hampshire C.C.; two would be transferred from Winchester C.C. to Eastleigh B.C.; and 19 would be transferred from Winchester C.C. to North West Hampshire C.C.

We should mention that a new ward, Badger Farm, was created from parts of the Compton. Olivers Battery, St. Luke and St. Michael wards by the City of Winchester (Parishes) Order 1985 with effect from 1st April 1985. The notice of our provisional recommendations omitted to refer to this Order and did not list the Badger Farm ward in the Winchester C.C., but it did list the four wards from which Badger Farm was formed. We also displayed maps in the constituency showing the area concerned. We consider that there could have been no confusion since the area and boundary of the constituency and the electorate were correct.

The Basingstoke and Deane (Parishes) Order 1985, which came into operation on 1st April 1985, changed the boundaries of some of the parishes within the Borough of Basingstoke and Deane and, in consequence, altered the ward boundaries which formed part of the constituency boundary between Basingstoke C.C. and North West Hampshire C.C., affecting 130 parliamentary electors. Our provisional recommendation was that the constituency boundary be altered to conform with the new ward boundaries, transferring the 130 parliamentary electors from North West Hampshire C.C. to Basingstoke C.C.

Five representations were received relating to the eight constituencies under review in Hampshire. The East Hampshire Conservative Association, the Eastleigh Conservative Association, the Fareham Conservative Association and the North West Hampshire Conservative Association raised no objection to our proposals. However, in noting the growth of the electorate in his constituency, the Member of Parliament for Eastleigh, Sir David Price D.L., repeated his personal view that the Woolston ward should not have been detached from the City of Southampton and included in Eastleigh B.C. This option had been rejected after careful consideration during our third general review on which we reported in February 1983 and none of the Southampton constituencies were included in this interim review. We have now confirmed that we do not think that it is appropriate for the Commission to recommend major changes in the constituencies between periodical general reviews, save in exceptional circumstances.

The Winchester City Council wrote subsequently to confirm that they had

no representations to make on the proposals.

We recommend the adoption of our provisional recommendations.

(ii) The county constitutencies of Falmouth and Camborne, St. Ives, South East Cornwall and Truro.

The Restormel (Parishes) Order 1983, which came into operation on 1st April 1983, created new parishes within the Borough of Restormel and, in consequence, altered a ward boundary which formed part of the constituency boundary between South East Cornwall C.C. and Truro C.C. This affected six parliamentary electors. Our provisional recommendation was that the constituency boundary should be altered to conform with the new ward boundary, transferring the six electors from Truro C.C. to South East Cornwall C.C.

The Kerrier (Parishes) Order 1985, which came into operation on 1st April 1985, created a new district ward of Constantine and Gweek within the District of Kerrier and, in consequence, altered the ward boundary which formed part of the constituency boundary between Falmouth and Camborne C.C. and St. Ives C.C., affecting 246 parliamentary electors. Our provisional recommendation was that the constituency boundary should be altered to conform with the boundary of the new ward, transferring 246 electors from St. Ives C.C. to Falmouth and Camborne C.C.

The Carrick (Parishes) Order 1985, which came into operation on 1st April 1985, changed the boundaries of some of the parishes within the District of Carrick and, in consequence, altered a ward boundary which formed part of the constituency boundary between Falmouth and Camborne C.C. and Truro

C.C., affecting 11 parliamentary electors. Our provisional recommendation was that the constituency boundary be altered to conform with the new ward boundary transferring the 11 electors from Falmouth and Camborne C.C. to Truro C.C.

No representations were received about our proposals in Cornwall. We now recommend the adoption of our provisional recommendations.

The North Yorkshire and West Yorkshire (Areas) Order 1982, which came into operation on 1st April 1983, altered the county boundary which formed the constituency boundary between Keighley C.C. and Skipton and Ripon C.C., affecting 111 parliamentary electors. Our provisional recommendation was that the constituency boundary be altered to conform with the new county boundary. Four representations were received within the statutory period of one month: North Yorkshire County Council, West Yorkshire Metropolitan County Council, Skipton and Ripon Conservative Association and Keighley Constituency Conservative Association accepted our proposals without objection. The Aire Valley Branch of Skipton and Ripon Constituency Conservative Association wrote soon afterwards to welcome our recommendations. We recommend the adoption of our provisional recommendations.

Our provisional recommendation was that the constituency boundary be altered to conform with the new ward boundary transferring the 10 electors from South East Cambridgeshire C.C. to North East Cambridgeshire C.C.

The South Cambridgeshire (Parishes) Order 1984, which came into operation on 1st April 1985, changed the boundaries of some of the parishes within the District of South Cambridgeshire and, in consequence, altered the ward boundaries which formed parts of the constituency boundary between South East Cambridgeshire C.C. and South West Cambridgeshire C.C., affecting 25 parliamentary electors. 




